All efforts will be made to deliver SMS alert to the registered mobile number of the candidates. However, **the Board will not be responsible for non-delivery of such SMS due to change in mobile number and/or technical reasons**. The candidates shall have to produce the printout of their e-Admit cards at the allotted venues for appearing in the said test with a proper and original proof of identity. Candidates are directed to carry identical photographs along with proof of identity as mentioned in the Admit card for the test.

Neither any paper Admit Card for Final Written Test will be issued or sent by post to the candidates who have applied on-line **nor** will it be made available from the office of the West Bengal Police Recruitment Board. Paper Admit cards will only be issued in respect of **off-line candidates**. The candidates are strongly advised not to carry any articles declared as prohibited in **Sl. No. 10 of Important Instructions** given in the Admit card.
