8. Incomplete / illegible applications will be deemed invalid and rejected without intimation to the candidate. Only the eligible candidates will be called for examinations.

9. It is made clear that merely fulfilling the basic essential qualification requirements does not automatically entitle a person to be called for tests. The selection will be made strictly on the merit basis. The decision of appointing authority regarding selection / rejection will be final. It is also made clear the the numbers of posts/vacancies are tentative and recruitment process can be cancelled / suspended / terminated by the Commandant at any stage, due to administrative reasons.

10. To reduce the number of candidates for written examination for one category of post, screening of applications will be carried out based on the percentage of marks obtained in the examination mandated as essential qualification required. Minimum ratio of 01 : 50 per post for each category to be maintained for such cut offs. A bench mark percentage will be fixed depending on the number of applicants. No screening of application is required in case of physical test wherever required. The candidates who fail to qualify in the physical test (wherever applicable) shall not be permitted to undergo written test. Skill test wherever applicable, will be conducted after written test and will be qualifying in nature. No weightage will be given for additional / higher qualification.
